PENNSYLVANIA ENVIROTHON Oral Presentation Component Rules and Guidelines

The oral presentation component is mandatory and all teams participating at the Pennsylvania State Envirothon are required to participate. The oral presentation component will be scored separately from the field testing exams. The oral presentation score will be one-sixth of the overall score when combined with the five field test scores. Oral presentation component scores will be tallied and the high and low score for each team will be discarded and the remaining scores will be averaged.

The problem solving oral presentation component will be conducted as follows:

- The scenario for the oral presentation will be posted to the Pennsylvania Envirothon website
 (www.envirothonpa.org) Station Training Oral Component page on Monday, May 14, 2018. It will also be
 emailed to all county Envirothon coordinators on this day. This will give most teams' ample time to prepare.
- 2. Teachers/Advisors should NOT prepare their team's presentation, but to only provide general guidance, such as review the rubric and clarify the scenario. Questions about the content of the scenario will not be answered by the Pennsylvania Envirothon (i.e. interpret the scenario on your own).
- 3. The oral presentation component will take place during the first day Tuesday, May 22, 2018. Teams should plan to register at least one hour and fifteen minutes prior to their assigned presentation time.
- 4. A time schedule is included with the registration packet and the team must show up for their scheduled time. If there is a conflict with this time, the team must contact the Pennsylvania Envirothon at the numbers listed below.
- 5. Each team member <u>may bring</u> his/her prepared note cards (no larger than 4" x 6") for the presentation. No other items (props, notes, tablet paper, etc.) may be taken into the preparation room.
- 6. No electronic devices are allowed during ANY part of the oral component (prep and/or presentation).
 - Each team will have one (1) hour prior to their assigned presentation time to practice its presentation and to prepare any props/visuals for use during its presentation. Visit the Pennsylvania Envirothon website (www.envirothonpa.org) Station Training Oral Component page for a complete listing of items that you will receive to prepare your presentation props/visuals. Teams are permitted to use only the materials provided by the Envirothon to prepare any visuals they would like to use during their presentations. Teams are not permitted to use or bring any other materials except for their notecards.
 - Teams will be permitted to carry their props/visuals and notecards from the preparation room to the presentation room.
- 7. Five minutes before the team's assigned presentation time, the team will be escorted to its presentation room. (Team advisors are permitted to view their respective team's presentation with the team members' approval.)
- 8. Each team will have 10 minutes for its presentation before a panel of five seven judges. The judges will then have up to 10 minutes to ask questions. Presentations must be at least five (5) minutes long but no longer than 10 minutes.
- 9. Team members are required to wear appropriate clothing that does **NOT** identify their school or county origin.

2018 Pennsylvania Envirothon Oral Component Presentation Prep Material

The Pennsylvania Envirothon will provide each team with the items listed below. These are the only items a team is permitted to use to develop all visuals/props that it will use during its presentation at the Pennsylvania State Envirothon. Teams are not permitted to use or required to bring any other materials.

One hour prior to a team's scheduled presentation time, each team will receive a CLEAR PLASTIC FOLDER, which will have the following prep materials enclosed.

- GREEN FOLDER * (Please return ALL documents included in the red folder in the same condition that you received them to the prep room monitor. Other teams will be using this same information folder; do not write on or destroy any of the documents**.)
 - Oral component Scenario and Judging Sheet**
 - Tips for Prep/Delivery**
 - Rules and Guidelines**
- 1 package of Sharpie Fine Point markers (12 count)*
- Permanent markers, 1 each black, red, blue, and green*
- 1 roll of clear tape *
- 1 glue stick *
- 5 pencils *
- 2 pair of scissors *
- 1 pencil sharpener *
- 1 ruler *

The Pennsylvania Envirothon will also provide each team with the following items that you are <u>permitted to write on</u> and use as presentation props/visuals.

- 4 sheets of white poster board (22" x 28")
- 5 sheets each of red, blue, yellow, and green paper
- 6 sheets of white tablet paper
- 50 blank notecards
- Aerial photo of farm- poster-sized (each team will have their own poster-sized map to write on/edit as needed and take to the presentation as a visual aid)
- 8.5 X 11" soil map of the farm
- 8.5 X 11" contour map of the farm

Teams are permitted to keep the above listed items. These do not need to be returned to the prep room monitor.

*The Pennsylvania Envirothon will provide two easels and a roll of painter's tape in <u>each presentation room</u>. These items are to be left in the presentation rooms and should not be removed by any teams.

As indicated in the Rules and Guidelines, each team will have one (1) hour prior to their assigned presentation time to prepare any props/visuals to be used during the presentation and to practice their presentation. Teams are permitted to use only the materials (listed on above) provided to prepare any visuals/props they would like to use during their presentations. Teams are not permitted to use or required to bring additional materials.

Teams will be permitted to carry their props/visuals and notecards from the preparation room to the presentation room.
